If these comments help (and noting I am no expert in numbers of or physics);

1. the latest CIMA report maybe changes the view on earlier reports from Golder/CIMA in that the comparisons of the LINC and RHVP only took into account those two roads and, now with comparison to other more comparable roads it might be a better conclusion that the LINC performs very well in comparisons to any road similar to Red Hill, probably helped by being almost strait and devoid of hills, and, the Red Hill performs close to or within the range of comparable roads probably affected by the amount of hills and curves, with the most out of range portion/numbers being in one direction (which suggests the numbers are *not* so dependant on paving conditions).
2. While the latest report is very helpful you wonder if a more complete report with even better comparable road sections might not add or take away from the above, but its important to remember all these reports will be accessible and maybe they don't want to keep ordering more unless its necessary.

Gord's chronology, which is mostly about his role as opposed to about the road, points out 'microsurfacing' was recommended I believe in or around 2013 and it seems likely this was not done even if later reports the City received didn't repeat the recommendation.

Maybe David might recommend if we need to do anything with these various experts who write reports so far if we need to retain them for testimony in potential litigation matters to prevent =anyone else from doing so.
